EMPHASIS**

The Master of Public Administration program focuses on concepts and skills needed to effectively manage organizations operating outside of the traditional business environment.

The MPA program requires successful completion of 45 semester credit hours, and offers students a choice of three emphases: government management, nonprofit management and healthcare management. Students must declare an emphasis prior to graduation; successful completion of an emphasis is noted on transcripts. Total program length varies based on the number of courses taken per eight-week session.

- Government Management

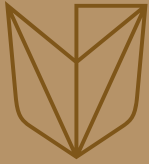
